Pursuant to an Agreement and Plan of Merger, dated March 26, 2019 (the "Agreement," attached hereto as Attachment 3(b)-1), Centene Corporation will, via an indirectly wholly owned subsidiary, acquire 100% of the voting securities of WellCare Health Plans, Inc. 


