Notice is hereby given that the Insurance Commissioner of the State of Connecticut will conduct a public hearing concerning the proposed plan of reorganization of Connecticut Medical Insurance Company Docket No. EX 20-24 on August 14, 2020 at 9:00 a.m. Pursuant to Executive Order No. 7B issued by Governor Ned Lamont on March 14, 2020, this hearing shall be held remotely via telephone. Members of the public can attend this hearing via telephone by dialing 877-912-5988 and using passcode 7299385.

The hearing will be conducted regarding the proposed reorganization of Connecticut Medical Insurance Company as a stock insurance company indirectly owned by a mutual holding company (the 'Proposed Reorganization'), in accordance with the terms of the Plan of Reorganization of Connecticut Medical Insurance Company (the "Reorganization Plan"), as set forth in the application filed by Connecticut Medical Insurance Company, dated January 31, 2020 (the "Application"). The Application requests the Insurance Commissioner's approval, as required by Section 38a-156a(c) (3) of the Connecticut General Statutes, of the Proposed Reorganization of Connecticut Medical Insurance Company. The official record of this proceeding, which includes a copy of the Application and the Reorganization Plan, is on file with the Connecticut Insurance Department, 153 Market Street, 7th floor, Hartford, Connecticut and may be accessed https://www.catalog.state.ct.us/cid/ portalApps/cmic.aspx

The hearing will be held pursuant to Section 38a-156a(c)(1) of the Connecticut General Statutes on (i) the reasons for and purpose of such Proposed Reorganization, (ii) the fairness of the terms and conditions of the Reorganization Plan and (iii) whether the Proposed Reorganization is in the best interests of the domestic mutual insurer, is fair and equitable to its members and is not detrimental to the insuring public.

Any director, officer, employee or member of Connecticut Medical Insurance Company shall have the right to appear and be heard at the hearing. Written statements may also be filed with the Insurance Department prior to the close of business on August 11, 2020, by mailing or delivering such statements to the Connecticut Insurance Department, PO. Box 816, Hartford, CT 06142-0816, Attention: Jared T. Kosky, Esq.
