Any director, officer, employee or member of Connecticut Medical Insurance Company shall have the right to appear and be heard at the hearing. Written statements may also be filled with the Insurance Department prior to the close of business on August 11, 2020, by mailing or delivering such statements to the Connecticut Insurance Department, P.O. Box 816, Hartford, CT 06142-0816, Attention: Jared T. Kosky, Esq.
